### Study: Retiree Membership, Not Name Change, AFPAAA's Present & Future Challenge

The biggest challenge facing AFPAAA in the immediate and long-term future is gaining younger retired members to bolster an aging membership base and changing the name of AFPAAA would not help meet that challenge.

Those were the conclusions of the committee formed in response to questions raised at AFPAAA's Annual Membership Meeting last year.

Bud Ross, who headed the committee, briefed the results of its efforts at the 18th Annual Membership Meeting in May. (The text of the Executive Summary of the report is on page 13. The full report is available at AFPAAA's web site: www. afpaaa.org

To reach its conclusions, Ross and the other committee members, Neil Buttimer and Dave Shea, assisted by Art Forster, reviewed past studies, membership trends, and member feedback over the years. They also met with SAF/PA Director of Public Affairs Brigadier General Les Kodlick to get inputs from the active force.

The size of the officer, enlisted, and civilian Public Affairs community has shrunk substantially since the Vietnam era which means the pool of retirees who are potential members is smaller.

A F PA A A n e e d s t o concentrate its recruiting efforts on those who are about to retire as well as those who retired in the past two decades. Current members are asked to reach out to those they served with and urge them join - a membership application is on page 15.



#### Willis L. Helmantoler

Bill Helmantoler, who turned down a contract to act at Paramount Pictures just prior to the outbreak of World War II, became a decorated pilot and commander of an air/sea rescue detachment, and, after it became a separate service, one of the pioneers of Air Force Public Affairs, died March 16, at Renaissance Gardens, Springfield, Virginia. He was 89.

Born in New Columbia, Illinois, he attended the University of Illinois. After WW II he remained on active duty and in 1949 was sent to Boston University where he earned his



bachelor's degree in public relations Summa cum Laude, and his master's degree a year later, capping that time with coauthorship of *The Public Relations Guide for Military Commanders*.

Bill's Air Force career was virtually a chronicle of major international and military events of the 1950s and 1960s. As Chief of Information for 5th Air Force and United States Forces Japan, he handled sensitive situations involving

shootings of Japanese by American servicemen.

He was the CINCPAC chief of information for Admiral U.S. Grant Sharp when the Tonkin Gulf incidents triggered the Vietnam war. Later he was assigned to the Office of the Secretary of Defense where he served much of his time as a liaison to the White House.

Bill was the "go to" spokesman in volatile situations, including going to Thule, Greenland when a B-52 carrying four nuclear weapons crashed. He was the DoD spokesman during the Chicago riots, preparations for the Paris Peace Talks, and the release of the Pueblo crew.

He retired as a colonel in 1969 to become director of public relations in Washington, D.C. for American Airlines until 1973. During this period. Bill returned to government service to head public affairs for President Nixon's Price Commission.

From 1973-78 he was with Carl Byoir & Associates, and from 1981-87 Creamer Dickson Basford. After four years running his own public relations company, he retired once more and wrote a novel set in WW II, *The Bonds of Earth*.

Bill is survived by his wife of 40 years, Mary Strader Helmantoler of Springfield – his first wife, Brickey Casey Helmantoler died in 1967; a son and daughter from his first marriage: Michael Helmantoler of Sandy, UT and Lynn Greene of Auburn, CA; a son, John Helmantoler of Midlothian, VA; nine grandchildren, and 15 great-grandchildren.

Interment at Arlington National Cemetery will be Wednesday, July 6, at 3 p.m. Memorial donations in Bill's name may be made to Grace Presbyterian Church, 7434 Bath Street, Springfield, VA.

Bill was a true pioneer in USAF and SecDef Public Affairs. He was Chief Public. Affairs officer at Fifth Air Force in Japan, the Air Training Command, and Chief of Media

Relations in SAFOI. He was Military Assistant to the ASD/PA and Chief of Public Affairs at PACOM. He was the Public Affairs Officer for the Vietnam Peace Meetings in Paris.

Bill was my mentor and friend for more than 54 years. He was honest almost to a fault but it earned him respect and friendship with media representatives around the world. I am truly proud to say I was his friend. Military Public Affairs officers owe Bill a great debt. We will miss him and remember his intelligence, wit, and dedication.

As Bill liked to say: "Last to know and first to go!"

#### Before Public Affairs: Heroics In WW II

Bill was attending the University of Illinois when he joined the Army Air Corps Aviation Cadets in August 1941, but his actual pilot training at Kelly Field didn't begin until after Pearl Harbor. After getting his wings, he was an instructor pilot at Pampa Army Airfield, Texas, for the rest of 1942.

He was transferred to the South Pacific for the remainder of the war. At 13th Air Force, Bill was an operations officer under Arno Luehman who, as a major general was Air Force Director of Information from May 1, 1957, to June 1, 1962. Bill flew more than 60 combat missions lasting more than 400 hours

in B-25s, B-17s, and OA-10s (the Army Air Corps version of the famed PBY Catalina). Later in the war he became commander of an OA-10A air/sea rescue



detachment in the Philippines that in one year of operations picked up 854 downed airmen at sea.

"My actual big mission was in the harbor of Zamboanga, Philippines," Bill related for AFPAAA's World War II remembrance booklet. "We rescued three

B-25 crews that had been shot down. We were in there for two hours and thirty-five minutes, and we were full of water and holes and couldn't get off for a long time. It was 18 people. One guy didn't make it; we only got 17. He couldn't get out of

the airplane. We could see him sitting in the airplane under



water and couldn't get him out."

Bill was awarded the Silver Star for that mission.



#### Gene J. Guerny

Gene Guerny, whose careers in the Air Force and at NASA spanned more than 60 years, died February 27, in his winter home in Kissimmee, Florida. He was 86 and was interred at Arlington National Cemetery.

Born in Fremont, Ohio, he earned

a BS in military science from the University of Maryland, and an MS and Ph.D. in Government Administration from George Washington University and Pacific Western University.

Gene served in the Air Force for 30 years. He was a command pilot with Strategic Air Command, then

became an Information Officer. He retired in 1973 as a lieutenant colonel.

While in the Air Force he began a literary career. He published 59 non-fiction books under the name Gene Gurney. They were on a variety of subjects, with many covering military and aviation history, as well as two encyclopedic volumes, "Kingdoms of Europe" and "Kingdoms of Asia."

After leaving the Air Force, Gene began a career at NASA's Goddard Space Flight Center, Greenbelt, Maryland, where he became chief of the Office of Public Affairs. He retired from NASA in 2005.

Gene is survived by his wife of 35 years Judith and two ex-wives Clare Guerny and Isabelle Wright, plus two daughters, Patricia Schmidt and Jeanne Bauer, four

Cam Stewart, Jr., died peacefully in his sleep January 21, 2 at Vanderbilt Medical Center, Nashville, Tennessee. He was 85.

He was born and raised in Montgomery, Alabama. In 1943, at 17, he joined the Army Air Corps Enlisted Reserve, entered active duty, and completed flying training as an aviation cadet. He was commissioned in August

1944 and served as a pilot, instructor pilot, and B-29 crew until November 1945.


After World War II, he became a member of the Alabama and later the District of Columbia Air National Guard, He returned to extended active duty in 1959 as an Air National Guard advisor to the Office of the Assistant Chief of Staff for Reserve Forces. In 1965, he became special assistant for Public Affairs to the Deputy for Reserve Affairs in the Office of the Secretary of the Air Force.

Cam accepted a Regular Air Force commission in 1967, and served as Deputy Executive

Officer to the Assistant Secretary of the Air Force for Manpower, Personnel, and Reserve Affairs. He volunteered for duty in Vietnam and served with the 14th Special Operations Wing, Nha Trang AB, and as Chief of Combat News, 7th Air Force Headquarters, Saigon, in 1969-70.

He returned to the Pentagon as Assistant Director for Reserve Readiness and Mobilization in the office of the Deputy Assistant Secretary of Reserve Affairs, and then grandchildren, one great grandchild and two brothers, Donald Gurney and Anthony Gurney.

Many of us were proud and envious of one Gene's earliest books - a coffee-table, photo and text book about the Pentagon. Gene got the text material and photos from the Army Historical people. He put the text



into readable writing, selected a variety of Army photos and produced а great product with relatively little effort on his part. The book was a dood seller.

upgrade and expansion of their computer capabilities.





## Air Force Advocate, Publisher Foy McNaughton Gets President's Award

The Air Force Public Affairs Alumni Association President's Award for 2011 was presented to Foy McNaughton, President and CEO of McNaughton Newspapers Inc., for his significant impact on Air Force public affairs, community relations, and his advocacy and support of the Air Force.

Mr. McNaughton received a plaque that included a small, red piece of the Cape Canaveral gantry used for the January. 31, 1958 launch of Explorer One, America's first satellite. The presentation was made by AFPAAA president Bud Ross.

The award is presented to individuals who are leaders in their particular field and who have significantly impacted U.S. Air Force Public Affairs.

Mr. McNaughton owns seven regional newspapers in Northern California, including the Fairfield Daily Republic. For two decades, he has made a significant journalistic contribution to military coverage of Travis AFB, the Air Force, and DoD in northern California, a region of the state in which military service has not always been fully appreciated and news media coverage often highly adversarial.

Unlike some community newspapers, whose reporters barely gain a foothold before their reassignment to another beat, the Daily Republic Management has maintained a beat military reporter who is well versed in military history. This has led to consistent, in-depth, accurate, and balanced reporting.

This reporter attends the monthly Travis Regional Armed Forces Committee (TRAFC) meetings to cover updates by military leaders. The paper also has a weekly section devoted to military news and publishes the Travis AFB Tail Winds newspaper.

Mr. McNaughton furthers base community relations through generous sponsorship of base events, both monetarily and in free advertising. As a past chairman and current board member of TRAFC, he has represented Fairfield to Congress in trips to Washington, DC.

His advocacy efforts with the TRAFC helped obtain congressional funding of a new Band of the Golden West building. During the past decade, congressional military construction appropriations above the

President's budget amounted to over \$300 million. He was recently chosen as the Travis AFB community representative to Air Mobility Command Commander, General Ray Johns.

"I've just had a feeling, for as long as I can recall, of the importance of what the military does for this country," Mr. McNaughton told those at the presentation luncheon at Travis AFB. In addition to members of AFPAAA, attending the luncheon were Brigadier General Les Kodlick, director of Air Force Public Affairs; Colonel James Vechery, commander of the 60th Air Mobility Wing; Colonel Gary Gottschall, commander of the 615th Contingency Response Wing; and Fairfield mayor Harry Price.

Previous recipients of the President's Award include former Secretary of the Air Force Thomas Reed, past Air Force Magazine editor John T. Correll, Frank Jennings, who coined the term "aerospace," and former Assistant Secretary of Defense for Public Affairs Bill Greener.

"It took a bit longer than we anticipated, but we have reached our endowment fund goal of \$300,000," Jim Hart, treasurer and head of the investment committee said. "That provides the base that will sustain AFPAAA's day-to-day operations in the years ahead,"

The goal, which was set in 1997, was reached in April because of a generally favorable stock market in the past year and 26 Centurion \$100 donations from individuals at the May Annual Membership Meeting. Since it began in 2003, the Centurion program has added almost \$18,000 to the fund.

"With the way the market has fluctuated in recent years, there is no guarantee that we stay above \$300,000 every day until our investments grow a bit more," Jim pointed out, "but I am confident that the firm that is managing our portfolio will continue to provide the conservative growth opportunities that have ensured the fund's success."

Morgan Stanley and Northwest Quadrant Wealth Management (NWQ) handle AFPAAA's funds. Our investment committee of Jim, Jim McGuire, and Hank Hufnagel work closely with them to ensure our goals and objectives are being met. Since the account was opened in 2001 AFPAAA has had and annualized return of just under 6%.

NWQ approach uses an approximate 60% equities - 40% fixed income ratio for the AFPAAA account.

The equities emphasize blue chip, consistent high performance companies such as ExxonMobil and Caterpillar. Corporate bonds, government securities, and cash are the rest of the portfolio.

The investment committee has a quarterly conference call with Morgan Stanley and NWQ to review the performance of the endowment fund and to chart the course of action for the next quarter. No member of the investment committee can make a unilateral decision regarding the funds.

"All donations to the endowment fund - money, stocks, real estate, collectibles, and other valuables - are tax deductible," Jim emphasized. "That helps the person making the donation reduce their tax liability while they help provide for the future of AFPAAA."

Cash donations have ranged from \$10 to \$10,000, stock donations have added almost \$20,000, and AFPAAA logo merchandise to raise funds has been contributed.

"We are in a good position now, but we can't get complacent," Jim cautioned. "As more members move from the annual renewal list to the paid for life list, the yearly stream of income from dues becomes less. And, while we have had fine support from industry, with the defense business climate what it is and proposed budget cuts likely to happen, we could see curtailment of that support."

**2010 AFPAAA Annual Membership Meeting Minutes** – President Bud Ross presented the minutes of the 17th Annual Membership Meeting for approval. Mike McRaney moved for approval, Dave Smith seconded and they were approved unanimously.

**Treasurer's Report** – Treasurer Jim Hart reported that per the bylaws requiring a report on the financial status of the Association A/O the end of the FY which is Sept. 30, 2010, the total balance of the Sun Trust checking account and the Endowment Fund was \$282,309.32. For an update Treasurer Hart reported that A/O Mar. 31, 2011 the balance if the two accounts is \$326,942.80. He advised the larger balance contains funds from registration for the 18th Annual meeting as well as corporate donations in support of the meeting. Those funds will be reduced as bills for the conference are paid. Finally Treasurer Hart reported that the quarterly financial report from Morgan Stanley, the managers of the Endowment Fund, showed A/O April 30, 2011 the balance stood at \$300,115.48.

President Ross thanked Treasurer Hart and Ron Rand for their efforts in seeking and raising funds from corporate sponsors over many years.

Motion was made by Rick Fuller to approve the Financial Report as presented, seconded by Jerry Dalton. Motion was approved unanimously.

#### **Committee Reports**

**Membership** – Provided by John Gura for Membership Committee Chairman Neil Buttimer. Current membership stands at a total of 544. Since last year's annual meeting, the Association membership has decreased significantly primarily due to non-renewal by associate members. We dropped 101 Associate members with two- year complimentary memberships that were not renewed. AFPAAAcontinues to maintain a core group of about 450 full (Annual, Lifetime Founder, and Lifetime) members. Essentially, the number of full members that fail to renew just about matches the number of new full members that sign up or transition from Associate to Full Membership.

**Web Site/Oral History** – Committee Chairman John Gura reported that we have enough material for four volumes. One has been produced so far. He advised that the CD has PDF files of the actual transcript of the interviews versus the voice version. He encouraged everyone to read them as they contain some very interesting material. **2013 Annual Membership Meeting** – Initial planning is for Las Vegas with John Gura serving as lead on the meeting.

#### New Business: None

**State of the Association** – President Bud Ross reported on the current state of the association. He noted we enjoy financial strength due to careful management by Treasurer Jim Hart, and membership is holding steady. We have seen some reduction in dues revenue due to membership conversions. With new faces stepping forward in leadership positions he thinks the Association will be in good hands. He does feel we face significant challenges as our membership grows older and the reductions in Public Affairs and allied career fields shrink the pool of potential members. He noted that Air Force actions to fill PA vacancies left by the major cut some years ago will result in the use of non-career PAs who may not be inclined to join our Association. He advised that membership is an issue that will need attention. He thanked those who have helped him throughout the year including Jim Hart and Chairman Christine Queen who was unable to attend the meeting.

**Membership Development Committee** – President Ross reported on his appointment by the Board last year to chair a committee to look at all the membership development issues, including the possibility of changing the name and how that might impact the Association's ability to attract those on active duty to join AFPAAA. Dave Shea and Neil Buttimer were the other members of the committee. It is a more complex issue than imagined. A complete report was included in each member's arrival package for the annual meeting. (see Executive Summary on next page) Key points from the report are:

- Association incorporated in 1994.
- This is the third committee to look at membership issue.
- Number one reason for AFPAAA to exist is as a means for retired/ separated to stay in touch.
- Committee thinks best action in next decade is to work those no longer serving.
- Name change can be done without impact on our charitable status.
- If you don't change the mission of an organization why change the name.
- Ops tempo, etc. supports the conclusion nothing will lead the young on active duty to join.
- Therefore the cost and work does not warrant the change.

Motion was made by Tom Halbert to accept the report, Jerry Dalton seconded, motion was passed unanimously.

President-elect Mark Foutch commended President Bud Ross for his challenging and successful year as President, Membership Development Committee chair, and Annual Meeting host. He expressed appreciation for the honor of being elected AFPAAA President and asked for the membership's support during his term beginning July 1.

Adjournment – With no other business, the meeting adjourned at 3:59 p.m. PST.

#### Summary of the Air Force Public Affairs Alumni Association Membership Development/Name Change Committee Report – May 2011

**Background –** The committee, headed by then President Bud Ross with Neil Buttimer and Dave Shea, who were assisted by Art Forster, was formed by AFPAAA's board of directors in July 2010 following a motion at the 17th Annual Membership Meeting in Orlando Florida in May 2010 to explore the membership challenges facing the Association and the possibility of changing its name to enhance its appeal to potential members.

**Findings** – The committee found that AFPAAA's membership will gradually decline over the next decade, and that a precipitous decline will occur in subsequent years. This will happen because of a likely large decline of retires over the next 20 to 30 years attributed to the substantial draw down of Public Affairs personnel since the high point during the Viet Nam era.

The greatest potential for immediate membership development rests in the current "no longer serving" group because the number of potential members in that group far exceeds those currently serving who would be candidates for membership in the future. Also, AF-PAAA's programs are designed to appeal to the no longer serving group.

According to the AFPAAA commissioned 1995 Gelb Study of its membership, the primary value to those who become members of AFPAAA is the social aspect of "staying in touch with friends and associates."

Although the committee was unable to survey those currently serving, it seems logical their social needs are being met by their frequent contact with their peers. Their professional development is provided by DIN-FOS, PME, The Short Course in Mass Communication, and Education with Industry.

Those currently serving are more likely focused on the present, both in terms of their duties and social relationships. AFPAAA is not structured to fulfill either those professional development or social network needs and appears to be not relevant to those currently serving. This is consistent with the purpose of AFPAAA to focus its activities on those who have retired from or are no longer serving in Public Affairs. Complimentary memberships for those now serving have yielded some awareness of AFPAAA, but not many gains in membership.

While changing the name of the organization by dropping the word "Alumni" is an option, and, according to one CPA, can be done without reapplying for tax exempt status so long as its purpose and operations remain the same, there is no proof a name change would increase the appeal of AFPAAA to those currently serving or increase their inclination to become members..

Additionally, it would cost both money (estimated at up to \$10,000), time, and effort. There is some concern that if the application for a name change somehow triggers additional review of AFPAAA's veteran's tax deductible donation status (90 per cent wartime members), that status could be in jeopardy.

Wartime service includes the Gulf War and "all later declared wars." All conflicts since Viet Nam have not been declared wars, further complicating the interpretation. Nonetheless, conflicts like Iraq and Afghanistan would likely be considered war-time service.

The committee concurs with the association's financial goal and its pursuit of growing the endowment fund to someday replace declining revenues from corporate donations. While revenue from membership dues has continued to wane, the corporate donations have cut membership costs at the annual meeting by about half and have become the major source of revenue.

#### **Recommendations –**

1. Efforts should continue to pursue membership from those now serving, but that additional effort be placed on those who have separated from the Air Force. The committee further recommends a new membership drive with incentives for membership recruitment be undertaken.

2. Absent any proof a name change will make a difference in recruitment of those currently serving, and because of the money and effort it would cost, the committee recommends keeping the organization's current name. Should the board decide to change the name, second and third CPA opinions on the risk to AFPAAA's "tax deductibility" status should be obtained before a change is made.

3. This study, as well as past studies of dues and membership, and name change decisions should be made a permanent record and communicated to the general membership.

4. Connection of AFPAAA with the active duty Public Affairs community needs to be reinforced. This might be achieved through a dedicated contact point. In addition, the leadership of AFPAAA should seek to be invited to MAJCOM and SAF/PA conferences to increase rapport and visibility with the active force.
